Terrance threatened Danny by placing a knife on his neck to force him sign an agreement to save his life. Explain the validity of agreement signed by Danny. Support your answer with relevant legislation and case law. (10 marks)

Later Ron wrote his promise on a piece of paper. Signed it and placed it on his wife's dressing table. In response, Lana told Ron that she will hold a grand dinner for the family and friends to celebrate the occasion. She will engage a famous caterer to prepare for the dinner at her own expense. Explain as to whether the promise made by Ron constitutes a valid contract. Support your answer with relevant legislation and case laws. (12 marks)
